# Version 27.21 (released 2020-04-27)

## **Bug fixes/changes:**

• Enhancements in the Qpick API

## Version 27.20 (released 2020-01-31)

## Bug fixes/changes:

- Declared value and currency code are no longer sent to LogTrade if a customs invoice is sent.
- Changed rounding principals for quantities, weights and volumes on customs invoice and delivery note.
- The Address type "Customs Fees Payer" was missing on released consignment address and in custom field mappings.
- Default Send Action = Validate in LogTrade Connect Setup resulted in Send Action = Archive on consignment
- Sender, Delivery and Recipient Address are now available as (default hidden) columns on Forwarder Invoice Lines
- Importing Invoices could lead to multiple questions if an invoice should be available for import in other companies.
- Forwarder Invoice lines with blank Tracking No. was aggregated.
- Automatic creation of customs invoices is now based on pickup and delivery instead of sender and recipient country codes (i.e. the physical movement of the goods).
- It was not possible to create a consignment from the customer card when using the LogTrade Connect extension for NAV2017 and NAV2018.

# Version 27.19 (released 2019-12-16)

#### Bug fixes/changes:

- Note of goods was not updated on automatically created consignment line.
- Unit price was not calculated on customs invoice for an invoiced sales order line.
- A new address type "Customs Fees Payer".

# Version 27.18 (released 2019-11-04)

#### **New functionality**

• A SOAP web service for creating consignments from e.g. handheld devices for pick documents (both inventory pick and warehouse pick).





A new report for cost reporting based on price quote amounts.

## Bug fixes/changes:

- It was not possible to link a source document to a consignment if the source document was used on a released consignment.
- Linking a source document tried to update the source document with Shipping Agent Code/-Service even if this was turned off in the settings.
- Freight charge lines on source documents are now inserted even if discount = 100%. Unit Cost is also updated on the source document line.
- Consignment address for recipient and delivery was not updated with VAT Registration No.
- When dangerous goods are created automatically it is now possible to create the consignment with a shipping agent service that does not support dangerous goods. The shipping agent service must then be changed to one that does before sending the consignment to LogTrade.
- It was not possible to delete a package with item lines or sub packages.
- It was not possible to use tracking <u>URL:s</u> on shipping agent that contained 'https'
- Shipment Note was not created correctly for consignments with linked source documents.
- Future shipment dates did not respect non-working days in the calendar.
- It was not possible to create consignment from sales order automatically if location codes weren't used.
- Calculated service parameter values of the type "Reference" did not calculate it's value
- Contact person on address of type Invoicing was fetched from sell-to/buy-from contact on the source document.

# Version 27.17 (released 2019-07-02)

#### Bug fixes/changes:

• There was a compilation error in codeunit 12057533.

# Version 27.16 (released 2019-06-27)

#### **New functionality:**

This version supports PDF printing as a complement to Integrated Printing. To enable this there is
a new setting in LogTrade Connect Setup: "Print Destination" with the options "Integrated Printer"
and "PDF".

- Automatic creation of consignments from posting of inventory pick did not filter the order automation setup on shipping agent and shipping agent service code
- Numeric values for service parameters was calculated double when service was inserted automatically based on service setup.
- VAT Registration No. was not fetched from customer or vendor when creating consignment without a source document.





# Version 27.15 (released 2019-05-29)

## **New functionality**

Internal unit for weight (kilogram or gram) can now be specified in the setup.

## Bug fixes/changes:

- When using order automation to create consignments from sales order and purchase order with multiple location codes the location code on the sales/purchase header could be changed.
- Consignments created on posting of inventory pick used the location code from the header of the source document instead of the location code from the inventory pick.
- Shipment Date can now be calculated based on Shipment Date on Warehouse shipment.
- Names and addresses on Consignment was always recalculated when changing shipping agent/service code even if the address setup was identical for the previous and new shipping agent service code.
- Booking Reference can now be specified on a consignment.
- When entering Volume on a consignment line width, length and height were cleared on packages. This is changed so these fields are only cleared if all three have a value (and thus have been used to calculate volume for the package)

# Version 27.14 (released 2019-04-25)

- It was not possible to use a number series as tracking no.
- Booking method "On Release" will (as in versions before 27.12) require sending the consignment as prepared before release.
- Reopening a prepared consignment and sending it again cold lead to that the consignment was updated with the wrong tracking if status was fetched from LogTrade using the Consignment Worksheet.
- Pages did not show up in search when using web client in Business Central on prem.
- It was not possible to create a new consignment using the web client in Business Central on prem
- It was not possible to create consignments from a warehouse shipment in Business Central on prem
- Weight on customs invoice line are now rounded upwards with precision 0.01
- The logic for linking source documents when creating consignments from a warehouse shipment are now case insensitive for the fields: Name, Address, Address2 and City.
- Selecting Agent Office could lead to a spill/overflow.
- It was not possible to use automatic posting of source documents on release of consignment.
- When using Order Automation to create consignments upon posting of inventory pick any errors in the consignment cancelled the update of the pick lines.
- No. series codes for Customs Invoice and Forwarder Invoice has been expanded from 10 to 20 characters in LogTrade Connect Setup
- Manifest ID has been added to the consignment.





• Blank country code was not replaced by Domestic Country Code specified in the setup.

# Version 27.13 (released 2019-02-12)

## **Bug fixes/changes:**

- Changing shipment date automatically based on shipping agent service calendar did not work as expected.
- When you select "Create Customs Invoice" the user will now be prompted to replace the existing customs invoice instead of opening the existing as previously.
- The quantity on customs invoice line was not calculated correctly when there where multiple items belonging to the same group in the invoice.
- It was not possible to create consignment automatically using order automation for purchase return order from inventory pick.
- The filter put on the lookup in "To Field No." in custom field mappings was not fully aligned with the filter declared in the table relation
- Checkout Instructions linked to Sales Header are no longer deleted together with the sales header (to enable the use of checkout instruction with consignment created based on posted sales shipment)
- It is now possible to apply web shop instruction created for sales order when creating consignment based on a sales shipment created from that sales order.

## Version 27.12 (released 2019-01-18)

- Free text lines were not printed on a LogTrade generated customs invoice.
- VAT number on Consignment Address was not sent to LogTrade.
- Source Document Type was cleared on a new consignment given a specific combination of setup.
- Address Source on Consignment Address was not set to "LogTrade On-line Query" when fetching an Agent Office from LogTrade.
- Status change on Package Header did not propagate down through all subsequent levels of sub packages.
- Costs from bundled packages was not rolled up to the consignment.
- It was not possible to lookup agent addresses if a service was required for LogTrade to return agent addresses (as with PostNord MyPack)
- It was not possible to print a prepared consignment.
- Booking Method can now be setup on individual consignments.
- It was not possible to setup booking method = "On Release" and send a consignment directly for release without sending as prepared first.
- Selecting Freight Payer = Other now creates a consignment address of type = Freight Payer.
- Truncation message was shown when using price quote if there was a field requiring truncation.
- Posted Sales Shipments are no longer updated with tracking number when Source Document Type = "Sales Order" since this caused issues for partial shipments.





- Limitations on string lengths for instructions has been removed.
- Actions for archiving released consignments has been removed.
- Location Code was not copied from posted documents when creating a consignment from the posted document.

# Version 27.11 (released 2018-10-15)

This version adds support for Dynamics 365 Business Central On Premises.

## **New functionality:**

• Support for Create/Add Goodsitem; A new setting on the product that, if enabled, allows adding/changing lines after a consignment has been sent to LogTrade.

## Bug fixes/changes:

- Line description on Customs Invoice was incorrect if any other grouping than "EU Tariff No."
- It was possible to setup a custom field mapping to consignment address without specifying address type.
- It was not possible to view consignment events from a released/archived consignment.
- New option value for posting in Order Automation Setup: Prepare. Please observe the changed order of the option values
- Truncated values can now be accepted automatically/silent by selecting "Auto Approve Truncation" in the setup.
- Payment Terms was not set on Customs Invoice and Shipment Note if Source Document Type was Sales Shipment.
- Automatic customs invoice did not work.
- Calculation of actual pickup time now use release datetime if there's no event for pickup from the forwarder.
- E-mail in Webshop Instruction has been extended to 70 characters.
- Webshop instructions are now editable from the consignment.
- A new setting in the setup that, if enabled, only creates consignments from Warehouse Shipment for lines that are registered as picked (or has a calculated quantity on the pick line if the setting that enables quantity calculation based on pick line quantities is enabled).
- A new setting on Forwarder Invoice Line Spec that determines if values should be summarized or not when aggregating duplicate package numbers.
- Consignment No. of Packages was wrong on Forwarder Invoice Lines.

# Version 27.10 (released 2018-06-01)

#### **New functionality:**

• A new table "Item Customs Values" where default values in LCY can be specified which will be used if the amount on the source document line is zero.





#### Bug fixes/changes:

- Prices on Customs Invoice lines was not calculated for source documents in local currency
- It is no longer possible to use custom field mapping for delivery fields on the consignment header since these mappings should be done towards the delivery address.
- To avoid zero amount customs invoice lines there's now a new table for Item Custom Values which is used when the source document line has a zero amount.
- It was possible to send dangerous goods with product not supporting dangerous goods by changing forwarder product.
- It was not possible to use sender address codes longer than 20 characters.
- Delivery and recipient address are no longer recreated when changing e.g. forwarder if Source No.
  is empty. This means that delivery name and address are not cleared when changing Shipping
  Agent/-Service on a "manual" Consignment (manual = consignment when name and address are
  not fetched from a source document or a customer, vendor etc.)
- The fields "Created By" and "Controlled By" on Package Header has been extended to 50 characters.
- Fields for EUR Pallet Customer No. has been extended to 10 characters.
- Reopening and resending a consignment now updates posted sales shipments with a new tracking number if the tracking number is changed and the source document still exists.
- Wrong Pickup name was displayed in the fact box on released consignment.
- Wrong fieldname was displayed when showing truncated values
- It was not possible to add linked source documents when the source documents name, address etc. had been truncated.
- It was not possible to use the function "Add Linked Source Documents" on a consignment if name, address etc. had been truncated on the consignment.
- A new checkbox "Only Empty Value" has been added to custom field mappings to enable the field mapping only if the target field is empty.
- Tracking URL's were not setup on Shipping Agents when using the LogTrade Connect Setup Wizard.
- The Order Automation codeunit raised a license error if the license didn't include adv.mgmt.
- It was not possible to post an inventory pick with "Ship and Invoice".

# Version 27.09 (released 2018-02-06)

#### **New functionality:**

- Support for NAV2018.
- Consignment can now be created/sent automatically when posting an Inventory Pick.
- The extension for changed standard objects now contain Package Type Shortcut Code, No of Packages, Gross Weight, Volume and Load Meters on Inventory pick. Together with automatic creation and sending of consignment on Inventory Pick posting, this means that it's possible to get labels printed automatically when posting the Pick.

#### **Bug fixes/changes**

• Bin Code are now supported for insert of cost item on inventory pick.





- Multi Language captions for charts were not imported correctly during setup.
- NAV2017 and later: It was not possible to download message log entries in the web client.
- Control ID's has been changed on extensions of pages to avoid conflicts with other changes in the same objects.
- Shipment date was cleared when changing shipping agent code
- Gate Code was not sent to LogTrade.
- It was not possible to use Ship-To Address or Order Address in Custom Field Mappings.
- Gross Weight, Net Weight and Volume can now be setup on Dangerous Goods Item Setup.
- There's a new option in the Copy Consignment function to copy sender address to recipient address.
- It was not possible to use costs with type Resource when Source Document Type was Service Order.
- Selecting Items to a package no longer requires the lines to be selected
- Automatic calculation of weight and volume on packages when selecting items from source document(s) or selecting sub packages. This also comes with updates of parent package and consignment when changing sub packages.
- Selection of packages now filters also on linked source documents.
- Unit Price calculation on customs invoice line now use the source document currency factor when the currency codes match to ensure that the unit price and amount from the source document is used.
- Permissions was created with full permissions for all permission sets when the codeunit that creates permissions was run for the first time. A second run updated permissions correctly.

# Version 27.08 (released 2017-12-18)

## **New functionality:**

 Order Automation: A new concept for more automated workflows including automatic consignment creation/sending and posting of source documents when validating/releasing consignments.

- A customs invoice created for a consignment with a drop shipment purchase order as source document will now use amounts and discounts from the sales order when creating the customs invoice.
- Weight, volume etc. can now be edited directly on the consignment line even if the line has been created by fetching a preexisting package. The requirement for this is that "No of Packages" = 1.
- Package tracking and released consignment list are now available from sales return order and purchase order
- Shipping Agent and Shipping Agent Code was not fetched from Service Order.
- It was not possible to use Print Method "On Release"
- It was not possible to use field numbers higher than 35 in Custom Field Mapping for Consignment Address





- Changes on delivery address (on consignment or on the delivery address) are now synced to the recipient address if all name-, address- and phone no. fields are equal.
- It is no longer a requirement that a forwarder or forwarder product needs to be active to use on a consignment.
- There is a new setting in the setup that controls if the Consignment shall be closed automatically after send/print or not.
- It was not possible to select and delete multiple archived consignments.
- Promised Delivery Date was not populated on Consignment or sent to LogTrade.

## Version 27.07 (released 2017-11-05)

## **Bug fixes/changes**

- It was not possible to setup a default property value without specifying a service
- The filter on Country/Region Code when searching for inhouse customer numbers was based on the Sender address. This has been changed so the filter is based on the Country/Region Code on the source document.
- Custom Field Mappings to Consignment Address with Type = Delivery did not update the deliver address fields on the Consignment.
- "To Table" and "To Address Type" were missing in the primary key for the Custom Field Mapping table

# Version 27.06 (released 2017-10-11)

#### Release Notes for NAV2017:

- If the extension for changes in standard objects are already installed, you must first uninstall and unpublish the extension. Then **delete codeunit 12057588** since that codeunit has been moved into the extension. Otherwise you'll get an error when publishing the extension. After importing the fob (or installing the LTC extension) you can publish and install the extension with changed standard objects again.
- The LTC2017 extension now also contains the standard objects, so it's a complete set of objects.
   The LTC2017 STD objects extension can therefore only be used together with the rest of LTC installed as objects.

#### **New functionality:**

- A new table "LogTrade Web Shop Instruction" that can be populated from a web shop integration with order specific values such as mobile phone no. reference, gate code etc., which the consignment will pick up when the source document number is validated. This table means that LogTrade Connect supports the new LogTrade Checkout functionality.
- The extension for standard objects in NAV2017 now includes new fields on sales order and sales
  return order (Package Type Shortcut Code, No of Packages, Gross Weight, Volume and Load
  Meters). If Package Type Shortcut has been specified these fields are used to automatically create a





consignment line. There's also a new action in to create and print a consignment. This means that printing labels from a sales order is now only one click away.

## **Bug fixes/changes:**

- It was not possible to import address setup where Forwarder Customer Number Source was "Freight Payer".
- It was not possible to import notification rules.
- Menu items for sales return order list was on the wrong page object in the extension for standard objects in NAV2017.
- It was not possible to use Boolean fields in Custom Field Mappings.
- Manually deleting released or archived consignments could cause errors with duplicate package ID's
- Manual change of Price Quote is no longer allowed is Automatic Price Quote = TRUE in the setup.
- Manual change of Price Quote now updates source document depending on the setup for that.
- The LogTrade Connect Role Center has been slightly changed.
- Price Quote from a source document now use Quantity from source document lines instead of e.g. qty. to ship. This makes price quote work also in locations setup for warehouse ship/receipt.

## Version 27.05 (released 2017-08-23)

Please read release notes for version 27 if you upgrade from version 26.04 or older.

#### **Bug fixes/changes:**

- There were still some license issues with SMS-integration on consignment status change for users without advanced management in the license.
- Missing multilanguage captions has been added for compliance with CfMD 2017
- The search for consignments to connect to a split consignment is now filtered on (and also triggered by) the location code of the split consignment.
- Validation of delivery post code on consignment did not calculate city.
- It was not possible to calculate actual shipping dates/times if the split consignment for a split consignment child was missing.
- The calculated value "Company Postal Giro No." in Default Parameter Value Setup was dependent on the Swedish localization. This has been changed to use recref/fieldref for this specific calculated value so the object will compile even in a non-swedish database.
- There's a new setting in LTC Setup that decides if and how Shipping Agent Code/-Service shall be updated on the source document. The default value is "Always".
- Linked source document numbers are now included in e-mails for external login, labels/documents and delivery notifications.

# Version 27.04 (released 2017-06-22)





Please read release notes for version 27 if you upgrade from version 26.04 or older.

## Bug fixes/changes:

- The update of "Sent to LogTrade" on consignment is now updated regardless if there's an answer from LogTrade or not. This eliminates the LogTrade error "Consignment with ID already exists" when the response from LogTrade for some reason wasn't received/processed.
- The function "CreateFromInvPick" has been removed from codeunit 12057533. The function "CreateFromInvtPick" should be used instead.
- "Do not use with EUR pallet customer No."-functionality on consignment costs did not work after upgrading to version 27.
- Automatic freight cost inserts on source document did not work since version 27

# Version 27.03 (released 2017-06-09)

Please read release notes for version 27 if you upgrade from version 26.04 or older.

## **New functionality:**

- A list of Customs Invoices can now be opened from the History menu.
- A new setting on the Forwarder Product makes it possible to automatically calculate Declared Value on the consignment.

- The functionality for Computer based Print Setup use a .Net variable that runs on the client. This is not allowed in the web client and there for the Computer based Print Setup is no longer supported for web clients (or any other non-windows client).
- The user will now need to confirm to add more than one freight line on the source document.
- It was not possible to create consignments for outbound transfers in whse. shipments.
- It was not possible to import settings for Address Setup.
- Opening source document after sending/printing now use modal view so the source document stays in focus.
- It was not possible to copy consignment from released consignment
- The setting for check of duplicate consignments has a new option value "Open existing" which means that it there's an existing consignment for the source document it will be opened when the user clicks on Create Consignment in the source document.
- The SMS functionality caused a license error when changing status in the Consignment Worksheet if Advanced Management wasn't in the license.
- Transport discounts can now be defined not only on Order Amount but also on Weight and Volume based on Source Document or Consignment (including package weights).
- Changes on the communication fast tab wasn't synchronized to the delivery address





# Version 27.02 (released 2017-05-15)

## Bug fixes/changes:

• There was an error (stack/overflow) when creating a consignment and automatically assigning Shipment Template Code through setup.

# Version 27.01 (released 2017-05-07)

This version solves issues with 3rd party payers.

#### Bug fixes/changes:

- All address types are now possible to create automatically using Address Setup
- Payer is automatically set to "Other" if a Consignment Address with Type = "Freight Payer" is created.
- If a Forwarder Customer No. is specified on a Custom Address, it is now used on the Consignment

# Version 27 (released 2017-05-03)

This version includes a major refactoring in how names and addresses are managed. Upgrading to this version requires data upgrade. Fobs for data upgrade are available for all supported NAV versions (2013 and later). 2013/2013R2 consists of Step1 and Step2 codeunits and from 2015 it's an upgrade codeunit. Please observe that **you need to be on version 23 or later when upgrading to version 27**.

Please test thoroughly and involve the customer before go-live since a lot of the functionality in the consignment has changed.

## **New functionality:**

- Addresses and customer numbers has been moved away from the Consignment Header table to a separate table with Consignment Addresses. Only the delivery address fields are available directly on the consignment (and kept in sync with the address with Address Type = Delivery in the new Consignment Address table.
- Print Method and Print Command can be specified on Forwarder Product.
- Support for Assisted Setup.





#### Bug fixes/changes:

- Special Quantity Code has changed from an option field to a code field with a lookup table
- The setting for Price Quote Automation has been split into two separate settings for greater flexibility: "Automatic Price Quote" (Y/N) and "Price Quote Source Doc. Update" (an option field that decides if and how the source document is updated).
- The setup table for Sender Address Code has been removed and the functionality incorporated in the new address management
- Freight Cost inserted on Sales Return Order and Purchase Order are now negative.
- The settings for automation of price quote has been split into two separate settings; One for automation of the price quote query and one for automation of source document update.
- Salesperson/purchaser Phone No. and E-mail can now be used as calculated values in the setup for default service property values.
- It was not possible to create SMS for received payments
- Individual packages were not updated if Total Weight on the Consignment Line was updated manually
- Registered Office has been removed from Customs Invoice since that field is a part of the Swedish localization.
- It is now possible to assign value to the field Payer with custom field mapping.
- Weight and volume were not calculated correctly for transfer orders and purchase return order when Warehouse Shipment was used.
- Forwarder Invoice Line now shows if the Consignment has already been invoiced.
- Delivery Notifications can now be specified by Location
- Delivery Notifications can now be triggered when saving Consignment to LogTrade (send as New)
- Package Weight can now be setup as "Goods Included" on Package Type Shortcut (as with Volume since before)
- "Goods included" as option for Weight Type on Package type Shortcut did not function together with automatically created Consignment Lines with auto assigned Packet Type Shortcut Code.
- Delivery Notifications (and other e-mails directly from LogTrade Connect) can now be sent in Norwegian.

# Version 16.08 (5.0 and 2009, released 2017-04-04)

#### Bug fixes/changes:

• The print functions have been aligned to recent changes in LogTrade to enable the print command.

# Version 26.04 (released 2017-03-09)

- It was possible to insert a blank line in the Shipment Template Setup table
- User ID in the Sender Setup table was only 20 characters





- The Computer Setup for Print Queue did not work since the mscorelib used for querying environment variables was run on the server.
- No. of Packages on Consignment Line is now limited to a maximum of 999.
- It was not possible to use a company/location name/address longer than 35 characters.
- It was not possible to print customs invoice from a released consignment.
- Blank currency code on Customs Invoice is now replaced by LCY Code from the general ledger setup.
- The print functions have been aligned to recent changes in LogTrade to enable the print command.

# Version 26.03 (released 2017-01-27)

## Bug fixes/changes:

- Changing Shipping Agent Service Code when using Package Type Shortcut with Pallet Type = Full resulted in wrong calculation of "No. of EUR half pallets".
- Multiple Custom Field Mappings for the same field number on the consignment raised an error when logging the change.
- Custom Field Mapping fetched the value from the source document even though the field mapping was setup to fetch from e.g. the customer.
- Changing Shipping Agent Service did not recreate the dangerous goods service if automatic selection of dangerous goods items wasn't enabled.

# Version 26.02 (released 2017-01-24)

## **Bug fixes/changes:**

 Custom Field Mappings now has a new field which controls if the target field shall be validated or not

# Version 26.01 (released 2017-01-23)

- LogTrade errors was not displayed correctly.
- Custom field mappings were "a bit tricky" to setup.
- Custom field mappings now perform a rollback to previous values on the consignment when changing values on the consignment, so the custom field mapping no longer applies.
- Datetime values from LogTrade without milliseconds was interpreted incorrect.
- User ID in Sender Setup was only 20 characters
- Service setup for dangerous goods are no longer created automatically since that's no longer needed and created problems on back orders.





# Version 26 (released 2017-01-17)

## **New functionality:**

- There's a new setting in the setup called "Internal Unit Measure" which decides if meter/cubic meter or decimeter/cubic decimeter is used internally in NAV.
- It is now possible to import/export forwarder mappings and additional product settings in the generic import/export tool.
- Freight Supplement Charge can now be specified on Forwarder Product which will (if set) overrule the generic setting. This way you can have different freight markups on different products.
- There are two new settings in LogTrade Connect Setup than enables automatic assignment of "Note of Goods" on Consignment Lines. This can be useful when consolidating consignments to keep references from the original consignment.
- Custom Field Mappings now support more filter columns (Shipping Agent, Shipping Agent Service Code and From Location Code) and fixed values. This way it is possible to automate gate codes, opal numbers etc.

- It is now possible to manually overrule the calculated number of pallets and pallet places on the consignment lines (first you must make the columns visible by "choose columns").
- Description and Description 2 in Dangerous Goods has been extended to 240 characters.
- A "division by zero" could occur when calculating cost.
- All volume, length, width, height and circumference fields are extended to allow 5 decimals.
- The recipient xml node was sent twice to LogTrade

- Free text longer than 250 characters in forwarder invoice cased the import to break.
- Long error messages from LogTrade could result in a spill/overflow error





- A new concept regarding send/print has been implemented. The behavior depends on the setup or "Print Method". If print method is "LogTrade Controlled" there's no longer a Send action. The user now selects "Print" and if the Consignment hasn't been validated it gets validated and printed (based on setup in LogTrade). After validation the Consignment is no longer editable until it's reopened. When a Consignment is reopened it is sent to LogTrade back to status "Saved" (formally called "New"). Printing a Consignment that is already validated will prompt the user for what to be printed. 

## **New functionality:**

- A rule-based notification functionality that sends e-mail on release, on prepare or manually with information about the Consignment, PDF-link, Tracking link etc. The primary targeted use is to notify shipping agents that do not support electronic bookings.
- Create LogTrade web users from LogTrade Connect.
- Links for External Login, Tracking, Labels, Bill of Lading etc. are now stored in a separate table for Consignment Links.
- Return Address fields on consignment and setup on Split point if Return Address shall be used and
  if it should be the standard sender (company/location address) or the inherited address from the
  Split Point.
- On Forwarder Product it is now possible to setup that a Consignment Line shall be created automatically and also a default "No. of Packages"
- Some support for the GUI changes in NAV2015 has been added. Mandatory fields are highlighted and the feature to hide Document No. is supported.

- The field "From Split Point" was not assigned automatically when values was validated based on a Source Document, only when manually validating i.e. "Shipping Agent Service Code".
- Unit Price and Amount on Customs invoice (forms/pages and reports) did not show values based on rounding settings on the Currency.





- When Source Document Lines are copied to Free Text Lines a filter is now set so only Items are inserted as Free Text Lines.
- If a scanned image for signature on Customs Invoice was not used a small icon symbolizing the empty picture was shown on the printout.
- Package Type Shortcut is now available on Dangerous Goods Lines.
- The form/page for Shipment Templates is no longer editable since Shipment Templates are fetch through the LogTrade Web Service API.
- The XML-structure for Consignments has been aligned to LogTrades new structure for Consignment Services.
- If sending requests to LogTrade has been deactivated a message is shown when trying to send a consignment that sending has been deactivated.
- Sending Consignments now support the new setting in LogTrade where you can set "Release on Prepare" = True. This means that even if you send the Consignment as Prepared (Swedish = Validerad) you will get the Consignment back as released.
- Products are now deleted if Forwarder is deleted.
- Allowable TOD are now deleted if Product is deleted.
- When updating Forwarders, you can now choose to only get new forwarders which will speed things up when adding new Forwarders in LogTrade.
- Consignment Costs and Linked Source Documents were not deleted when the Consignment was released, archived or deleted.
- It was not possible to send consignment with status "Validate".
- The function for Post Code validation is now using shipment date + 1 day in the case of the shipping agent has been setup for automatic booking. That would in other cases cause an error if post code validation was run to late during the day.
- Text line creation is now aligned with warehouse function, so the correct lines and quantities are created if the Consignment is based on a Whse Shipment or Invt. Pick.
- Changing Shipping Agent Service will now update planning parameters for delivery date on source document.
- If "No. of Packages" is set to zero, the Package Specification lines are now deleted.
- Field lengths for Code and Description in the Shipment Template table/fields has been increased to support the field lengths in LogTrade.
- When importing Forwarder Invoice amounts for additional costs was not inserted.

Since codeunit 12057544 no longer has an 2013R2-specific version you must remember to choose "Replace All" when importing the objects in R2.

This means that re sending an old consignment after upgrading to version 12 means that no weight or volume is sent to LogTrade. Therefore, the fields "Total Weight" and "Total Volume" should be assigned the values from the old fields. This can be done by using this report:

- Package Type Shortcuts can now be defined and mapped to actual Packet Types. This means that you can define i.e. a shortcut called PALL that you map to different packet types for different Forwarder Products. This makes it easier to choose Package Type since the same Shortcut Code can apply to different Package Type Names.
- Default Package Type Shortcut on Forwarder Product.
- Advanced Management: Packet Type Shortcut Setup with Weight, Pallet Places, Volume on Packet Type Shortcuts. Volume can be defined as Including or excluding the actual goods. New fields on





- consignment line: "Packaging Weight", "Total Weight", "Packaging Volume" and "Total volume". With these functions the weight/volumes for pallets etc. can be maintained automatically on Consignment Lines. Packet Type Shortcuts can also be linked to Cost Codes to enable automatic order lines for charging costs for pallets etc.
- If you specify the Service Shortcut for Dangerous Goods in the setup you will now get the service for dangerous goods automatically created for the consignment. If the Consignment is linked to a source document a Service Setup record will also be created so that the Consignment will not be possible to send if the Dangerous Goods service should be removed for some reason. It also works the other way around so that if the user inserts the Dangerous Goods Service (or it has been created based on Service Setup) the consignment will not be possible to send without entering one or more Dangerous Goods Lines linked to any of the Consignment Lines.
- It is now possible to define country specific text lines that will be inserted automatically as text lines when a Customs Invoice is Created.

- Several changes (along with some bug fixes) has been made in the functionality for Import of Vendor Invoices to support new invoice fields from LogTrade and new logic to support invoices from Posten Sweden. Since Posten Sweden sends invoices with Package Numbers on the lines instead of Consignment Numbers both functionality for replacing Package No. with Consignment No. and Aggregation of lines on Consignment No. level has been implemented.
- Relations on the fields Forwarder and ForwarderProduct was missing on the tables "Consignment Header" and "Finished Consignment Header".
- Layout changes in the LTC Role Center
- Shipping Agent Invoice reports has got grouping fixed in the RDLC versions and some layout changes.
- Gross Weight has been removed from Customs Invoice Line. The Gross Weight of a Customs Invoice are now based on the Total Weight of the Consignment Lines. You will have to remove any data in the "Gross Weight" field in the tables 12060670 and 12060672 when upgrading to this version.
- When copying Source Document Lines to a consignment manually the user must now confirm the copy and will be notified when the lines are copied.
- The document caption was not visible when printing a Customs Invoice to pdf.
- When sending Consignments Tracking No. was always cleared if "Cons. Tracking No. Assignment" on the Product was set to "LogTrade Controlled". This has been changed so that the first Tracking No. that is assigned by LogTrade will be reused if the Consignment is sent more than one time to LogTrade.

To show also the Package Types that are not marked as default the user must choose "Advanced" to open the list of Package Types and remove the filter on "Default". Please observe that the filter on Default does not work in 2009 RTC due to a platform bug.

# Version 11 (released 2013-12-27)

- Functions to call from Source Documents to query the Time Table (pick-up and delivery time)
- Functions to call from Sales Order, Purchase Return Order and Service Order to calculate the freight price and have it inserted as a document line.





- Function to call from Warehouse Shipment Line to create Consignment for the Source Document
  on the current Warehouse Shipment Line. This way it is possible to create consignments either for
  a Warehouse Shipment as a whole or for individual Source Documents on the Warehouse
  Shipment.
- Test Mode per user in the User Setup. Filtering of consignments based on Test Mode Yes/No meaning that you can switch between production mode and test mode for a single user in your production environment to do testing, training etc.

- There were rounding issues on weight and volume when creating Consignment Package Lines. This has been corrected so that all packages are rounded to two decimals and the last package takes care of the rounding residual, so the total of the Package Lines match the Consignment Line.
- The wrong Service Order list was opened from the LogTrade Role Center. This has been corrected.
- The field "Get Time Table Codeunit" in LTC Setup was not imported/exported by the import/setup tool.
- The Shipping Agent Invoice Import Specification Code had to be the same as the Excel Import Specification Code. This has been corrected.
- It was not possible to change Shipment method Code on a Consignment if the Source Document was released.
- Posted documents were not updated when changing Shipment Method Code on Consignment.
- Change of Shipment Method Code on Consignment did not update linked source documents
- When using a posted document as Source Document the Shipment date was calculated based on the posted document. This could lead to that a passed date was used as Shipment date on the Consignment.
- It was not possible to complete the last step in the Setup Wizard in NAV2009 unless there was a folder named "c:\temp".
- Characters like åäö did not work in 2009 RTC since 2009RTC requires UTF-16 while all other versions/clients work with UTF-8.
- When using price query, the local currency code is now shown on the consignment to avoid confusion since the Source Document can be in a different currency. As before the freight cost is converted to the currency of the source document.
- The field "Custom Data" on Consignment Header had the datatype Code(20). This has been corrected to Text(50).
- It was not possible to open the Consignment Card from the Linked Consignment List in RTC.
- Goods Type Description was 30 characters on Consignment Line. This has been extended to 35.
- Weight and Volume based on source documents was not calculated correctly when creating consignments with linked source documents (typically from the Warehouse Shipment Header.

# Version 10.02 (released 2013-11-27)

• The setting "Send Customs Invoice to LogTrade" worked the opposite way. A "NOT" has been removed in codeunit 12057520.






## Version 10.01 (released 2013-11-26)

 It was not possible to import Report Selections with the Import/export Tool. This has been corrected.

# Version 10 (released 2013-11-25)

This version supports 2013 R2 and are in many terms an RTC-release with a brand-new Role Center for LTC, fact boxes etc. Other big changes are the support for Warehouse Shipments and creating Consignments for already posted documents.

- The XML file logging on the file system has been replaced with table-based logging and XML files stored as blobs.
- There is now a Role Center for LogTrade Connect. Several pages have also been changed to include fact boxes with Consignment statistics. For the classic client statistics forms (F9) has been added. Some fields have been moved from the Consignment to the Consignment fact box.
- LogTrade Connect now supports Warehouse Shipments. One or more Consignments can be linked to a Warehouse Shipment and there is also a function to automatically created all consignments necessary for a Warehouse Shipment. (Advanced Management)
- To support Warehouse Shipments where several Source Documents for the same recipient can be treated at once it is now possible to link source documents to a Consignment. The consignment will have one "main document" and other source documents of the same type for the same recipient can be linked. Linking can be done manually, from a Warehouse Shipment or by using a function on the Consignment to find Source Documents for the same recipient to add as Linked Documents.
- Four new Source Document Types has been added:
  - Sales Shipment
  - Return Shipment
  - Transfer Shipment
  - Service Shipment
- There is now a function (CheckConsignment) in codeunit 12057533 that can be called from e.g. codeunit 80 to verify that a Consignment exists and is sent as Prepared. Otherwise the user is prompted to create or open the Consignment.
- The functions for Post Code verification now supports setting up Post Code Check Shipment Templates per Country and Shipping Agent instead of only per country as earlier. This means that you can test postcodes on customers, orders etc. with e.g. SCHENKER with one template and all others with a default template for that country.





- Country/Region Code is now a part of the primary key in the Payer Customer No. table meaning that it is now possible to have one customer number for e.g. Sweden and a different customer number for other countries on the same forwarder and product.
- The payment terms description copied to a customs invoice are now always in English if an English translation exists for the payment term.
- Many default settings for customs invoice has been added together with the possibility to import a picture for signature.
- There is now a document in NAV for Customs Invoice, and it is possible to choose in the setup if Customs Invoice should be printed by NAV or not. If printed by NAV it will be printed automatically if Print Method = "LogTrade Controlled" and the status after sending the Consignment is "Prepared" or "Released". This opportunity makes it easy to implement custom specific layout requirements for Customs Invoice.
- It is now possible to specify a Shipment Template Code on a Forwarder Product. If specified, the Shipment Template Code will be automatically added to the Consignment when validating the Shipping Agent Service Code that is linked to the product.
- It is now possible to call a LogTrade webservice from the Consignment to get the pickup date/time and delivery date/time for the Consignment. The answer from LogTrade is shown in a message box.

- The error message from LogTrade about missing Shipping method code/Leveransvillkor is now translated to "Terms of Delivery Code"/Transportvillkor.
- The Worksheet for Released Consignments referenced non released Consignments in all page links and the batch print function. This has been corrected.
- Sender reference for sales order was not populated with External Doc. No. from Sales Order or Vendors Order No. for Purchase orders. This has been corrected.
- Calculations of weight and volume are now based on outstanding quantity instead of Qty. to Ship. The reason for this is the support for Warehouse Shipment.
- All code for truncation in table 12057521 has been moved to a separate codeunit to make the code in the table more readable
- The definition of the service parameter calculated value "Outstanding Qty. to Ship Value" has been changed to "Qty. to Ship Value/Qty. shipped Value" (based on "Line Amount" instead of "Outstanding Amount") to support using posted documents as source documents.
- Terms of Payment on Customs Invoice are now populated automatically based on the Payment Term of the Source Document when Source Document Type = Sales Order
- It was not possible to create manual text lines in the Customs Invoice
- It is now optional if Customs Invoice lines shall be aggregated on source document descriptions. If not, aggregation will be on Tariff Number.
- It is no longer possible to enter package number manually unless the product is setup for manual package numbers
- Sender Address Code was not always cleared as it should when changing location code etc. This has been corrected.





- If "From Split Point Code" was cleared the sender and pickup information was not restored correctly. This has been corrected.
- If the user is linked to an employee in the user setup the "Sender Mobile Phone No." is now fetched from the employee. "Phone No. 2" from Location and Company Information is no longer used as "Mobile Phone No.".
- The Setup Wizard has been redesigned slightly to make setup more intuitive. The user is now prompted with a LogTrade logon dialog which after loon will load the forwarders and products and then open the wizard.

### Notes on upgrading from previous versions:

- You must make sure that the fields "Save XML Request" and "XML File Path" are empty before importing the objects since these two fields are removed in this version.
- If you are upgrading and are using RTC you must run codeunit 12057547 manually to initialize the charts used in the LTC role center.
- If you are upgrading and want to use the Time Table function you must setup the codeunit ID (12057549) for Time Table queries in the Advanced Setup.

## Version \*.09 (released 2013-09-11)

### **New functionality:**

- The 2013 version of LogTrade Connect now uses .Net for all web service communication, XML file handling etc. All COM variables and code has been replaced by .Net equivalents. This means that NAV Server can run the functionality in LogTrade Connect to use in situations with automation, handheld devices, web client etc.
- The Setup Wizard will now suggest three User Roles for permissions. The roles are "Settings", "Working with Consignments" and "Reader". When importing defaultsetings.xml the import will create table permissions for the three roles.
- If a consignment is sent to LogTrade with action "Save" and is later validated in the LogTrade GUI, the function that updates status on consignments in LogTrade Connect will now populate existing package lines with package number and create package tracking lines.
- Declared Value and Declared Currency Code has been added to consignment.
- Default settings on logtradeconnect.se/public are now version aware in that sense that every new release of LTC will suggest a different filename. Version 09 will suggest importing defaultsettings\_09.xml. The existing defaultsettings.xml is for version 08.

- Functionality for "Use Return Label" has been aligned with changes in LogTrade since this caused an error. The "Return Tracking No." is now also stored on the consignment when using return label.
- The checkbox "Use Source Doc Shipment Date" in the setup has been changed to an option field to allow consignments to be created with a blank shipment date which will be set to workdate when the shipment is sent for validation.





- A Forwarder or Forwarder Product that previously was inactive (existed in NAV but was removed in LogTrade) was not activated when it was re enabled in LogTrade again. This has been corrected.
- The import/export tool did not handle Vendor Invoice Import Specification. This has been corrected
- When searching for phone and e-mail when creating a consignment linked to a Sales- or Purchase Order the functionality was to first search for the "Ship-to Contact" (the name that is) among the customers/vendors contacts. If no match was found on the name step 2 would be to get the phone and e-mail from the customer/vendor. Before this second step we now look at the Sell-to/Buy-from Contact and tries to get phone, fax and email from that contact.
- There was a "IF GUIALLOWED" missing in codeunit 12057524. This has been corrected.
- The file path was not updated when choosing a file in RTC Import/export page. This has been corrected.
- There was an error when sending a consignment with more than one package with action "Save". This has been corrected
- Consignment lines and package numbers were previously fetched from Control Tower only if the consignment had been sent (as saved) to LogTrade without consignment lines. This has been changed so even if the consignment had lines when it was sent (saved) the lines will be replaced with data from Control Tower if Number of packages, weight, volume or any packing number has been changed in the LogTrade GUI before it was released in the web GUI. This functionality only applies to situations where a consignment is sent from LogTrade Connect and then validated and released in the web GUI (often by a 3rd party actor).

#### **Known issues:**

• The automatic deletion of xml debug files does not work in RTC if client and server run on separate computers (this is addressed in version \*.10).

## Version \*.08 (released 2013-08-06)

#### **New functionality:**

• There is a new setting in LogTrade Connect Setup called "Remove Country from Post Code" that if enabled will clear out Country Code (and any hyphen) used in the beginning of a post/zip code when sending post codes to LogTrade.

- If a status query was sent from the Consignment Worksheet and all consignments matching the filter was not sent (blank LogTrade Status) there was an error when requesting status from LogTrade. This has been corrected.
- New fields have been added to Customs Invoice Header.
- A bug was introduced in version 07.04 when "Source Address Code" was added to the list of keys in the Split Point Setup Table. This has been corrected.
- On the Consignment form the field "Mobile Phone No." on the communication tab has been moved to next under "Phone No.".





# Version \*.07.04 (released 2013-06-30)

### Bug fixes/changes:

It is now possible to also use "Source Type", "Source No." and "Source Address Code" in the Split
Point Setup which gives the possibility to link recipients to different split points within the same
country.

## Version \*.07.03 (released 2013-06-27)

- It is now possible to define on a Split Point if the connected "children" shall inherit the sender address from the address source that is defined on the Split Point.
- It was not possible to send Sender Address ID to LogTrade for Consignment linked to Sales Return Order or Purchase Order. This has been corrected.
- It was not possible to enter Package Specifications Lines without first inserting a Consignment Line. This is corrected so that the consignment line is inserted automatically when the Package Specification lines are summarized to update the Consignment Line.

- Consolidated consignments are no longer possible to modify or delete since all actions should be performed on the consolidation consignment.

- "LogTrade Status" and "Sent to LogTrade" has been added to the "picklist" where consignments are chosen to be linked to a split consignment.
- If you chose not to connect any consignments to a potential split consignment you would get that question one more time even though you answered "No" in the first place. This has been corrected.
- Codeunit 12057533 "LogTrade Std. NAV Integration" always warns for duplicate consignment when creating consignment from an Inventory Pick even though no consignment has been created for the pick. This has been corrected.
- When creating a consignment for a service order the Shipping Agent and Shipping Agent Service are now fetched from the Customer (or Ship-To Address if the Service Order has a Ship-To Address) since the Service Order does not carry information about Shipping Agent/-Service.
- It was not possible to update a Service Order with Price Quote or Costs. This has been corrected.
- The warning that source document lines has not been copied to the consignment was shown also for price quote requests. This has been corrected.





• When source document lines were copied into free text lines also price quote lines and consignment cost lines (i.e. source document lines that has been created from the consignment) were inserted as free text lines. This has been corrected so that only the original source document lines are used as free text lines.

- Source document lines can now be used to create Free Text lines for printout on certain documents.
- It is now possible to send a link in an email for downloading PDF's to e.g. the customer.
- It is now possible to send a link in an email to the consignment to e.g. a vendor so that the vendor can use LogTrade to complete and send the consignment. This requires additional license in LogTrade.
- It is now possible to send a link to the consignment to e.g. a vendor so that the vendor can use LogTrade to complete and send the consignment. This requires additional license in LogTrade.
- If consignment is sent to LogTrade with status "New" and the consignment is completed and released in LogTrade web GUI the functionality that updates the status from LogTrade also can fetch package lines and tracking information from Control Tower.





- It is now possible to setup Replacement Post Codes that is used when sending a consignment instead of the actual post codes on the Consignment. The reason for this functionality is that some forwarders/shipping agents has outdated post code tables.
- The "Default Send Action" has been removed from Forwarder Product and the setting of default send action is now done with a setup table where it's possible to set rules based on forwarder, forwarder product, source document type, source type etc.
- Advanced Management: It is now possible to setup cost codes linked to accounts, items, item
  charges or resources. These cost codes can be used to add costs to consignments and have source
  documents updated with order lines for the entered costs. Cost codes can setup as
  full/half/quarter EUR pallets, so the consignment is automatically updated with the right number of
  pallets.
- Advanced Management: Split Consignments are now supported. It is now possible to set rules on Shipping Agent, Shipping Agent Service and Country so that the recipient address will be a Split Point. This will be the "mother" consignment. The "child" consignments will automatically get the Split Point as Sender- and Pickup address. The Customs Invoice will be created on the "mother" consignment" and show values as totals from the connected "children".
- The Default Sender Address ID has been removed from LTC Setup and Location Setup and is replaced by a table for setting up default Sender Address in a more flexible way based on "From Location Code", "Source Document Type", "Source Type" and "Source No."
- Multilanguage support. The LogTrade languages (SV and EN) can now be mapped to the NAV languages (SVE and ENU) so that error messages are shown in English if ENU is used. This also affects service parameters which from this release are shown in Swedish or English depending on the chosen language in the NAV client.
- It is now possible to set a default location code on the user in the User Setup table. This can be used to automatically fetch the correct Sender ID based on the settings in the Sender Setup table. The default location will be overridden by any location given by the source no. or the source document.

The imported data can then be processed to assign additional costs to invoice lines. The invoice lines are matched to consignments and updated with consignment data for reporting purposes. The consignments are also updated with invoice data.





- If a Sales Return Order has a Ship-to-Code the pickup address data is now fetched from the Shipping Address.

Version \*.06 is from a user perspective mainly about services. This version also supports agent offices received from LogTrade through web services based on recipient address.

For you as a partner the setup wizard has been more streamlined and easier to use with file open dialogs, easier import of shipping agent mapping data etc.

## **New functionality:**

- It is now possible to specify more parameters for default services. It is now possible to use also these fields when setting up the prerequisites for a default parameter to be applied:

- It is now possible to setup generic service shortcuts for e.g. e-mail which is linked to all similar services in all products. It is also possible to setup default services on different combinations of Shipping Agent/-Service, Source Document Type, Source Document No., Source Type, Source No and Source Address Code. This way it is possible to setup that e.g. an e-mail advice service shall be used for a specific customer regardless of shipping agent/-service. It is also possible to use this default setup for specific documents so e.g. a salesperson gives instructions to be used by the yet not created consignment. On the shortcuts (inherited down to default services) it is possible to set if the service is mandatory or if the user can confirm a missing service. This way it is possible to setup mandatory services for e.g. a customer or that e.g. CashOnDelivery is mandatory.
- It is now possible to look up a list of available Agent Offices in the field "Agent Office ID" on a consignment. The lookup triggers a web service request to LogTrade which returns the available agent offices based on the location of the recipient. It is also possible to display an agent office in Google Maps (or any other web-based map service accepting longitude and latitude as parameters).
- It is now possible to setup default send action on individual forwarder products that will (if set) override the Default Send Action in LogTrade Setup.

- The import of shipping agent mapping blanked out Shipping Agent Code on the Forwarder if the last forwarder product for the forwarder was not mapped to a shipping agent service. This has been corrected.
- The user interface in the Import/Export tool and the file management in the Setup Wizard has been reworked.
- The XML import for setup data did not handle Boolean fields correctly. This has been corrected.

- The functionality for truncating values from standard NAV into shorter fields in LogTrade Connect has been partially rewritten to make the functionality easier for the user and more flexible so the same functionality also can be used for phone numbers, e-mail addresses etc. The truncation code now looks at the actual field length instead of a parameter in the setup to decide if truncation is needed.

- The field "Paying Customer No." was editable when Payer = Recipient. This has been corrected.

# Version \*.05 (released 2012-11-30)

 It is now possible to create a customs invoice linked to a consignment automatically (if there is a source document) or manually given that the recipients country code is not blank and not an EU country. The Customs Invoice is printed together with the other LogTrade documents.





- The default shipment date can now be based on the source document.
- Sender Reference now has its own field on the consignment instead of using Source Document No.
  This makes it possible to create consignments without using a source document where the
  Shipping Agent Service requires a sender reference (such as DHL Express). By default, the Source
  Document No. is used to populate the Sender Reference field.

- If validated shipments were released in the LogTrade Web GUI instead of using the Consignment Worksheet, an error occurred if you after that tried to release the consignments in NAV. This has been changed so no error message is shown. Instead these consignments are left in the worksheet and it is now possible to update status from LogTrade by choosing "Update Status from LogTrade". This way the consignments will be released also in NAV. If "Update status in Worksheet" is enabled in setup the consignments will also be updated automatically when the worksheet is opened.
- If the xml-filed used by the import/export function did not exist, the user had to close the import progress dialog manually. This has been corrected.
- If Settings where to save XML response but no path for XML file was setup the Service Tier tried to save the response in an unpredictable folder often with an access violation error as result.
- When using "Address Code" without a Source Document the Post Code was not populated. This has been corrected.
- When using Address Code with Source type "Customer" and no source document the Shipment Method Code was not fetched from the Ship-to Address. This has been corrected.
- When changing Post Code on a consignment with no source document but with a source address code (shipping/order address) the customer/vendor was updated with the new post code instead of the customer/vendor. This has been corrected
- When changing Post Code on a consignment with a sales document with a ship-to address <> " as source document the ship-to address was not updated with the new Post Code. This has been corrected.
- It was not possible to disable saving of password in xml debug files. This has been corrected.
- It was not possible to drill down in "No. of services" on Consignment. This has been changed so that drill down is possible, and no. of services updated on return to the Consignment
- When drilling down from "No. of missing parameters" on a consignment service only the missing parameters where shown. This has been changed so that all parameters for the service are shown.
- When a service is added which has a parameter of the type "CurrencyCode" the currency code is automatically fetched from the source document (or the source no. if there's no source document). If the currency code still is blank it is automatically set to the LCY Currency specified in General Ledger Setup (regardless if that currency code exists as a currency). Otherwise it won't be possible to send the consignment using local currency without setting up the local currency as a currency since that parameter would miss a value.

# Version \*.04 (released 2012-11-14)





• Bookings is now supported. Bookings can be LogTrade controlled, Automatic on validation, Automatic on release or Manual. Booking can be done both from the Consignment Worksheet and from a Consignment. Please note that not all Shipping Agents support bookings.

### Bug fixes/changes:

- More than one Consignment Line with different package types was not transferred to LogTrade correctly. this has been corrected.
- Data Caption Fields has been added to form and page 12057577.
- Correction of translation in form and page 12057531.
- If LogTrade sent back more than one instance of a service when requesting services for a product this would raise an insert error in NAV. This has been corrected.
- Package Type Description is no longer sent to LogTrade since this raised an error in LogTrade when descriptions were longer than 25 characters.
- The Print Option "On Release" did not work when releasing directly from a consignment. This has been corrected.
- The Print Option "On Validation" did not work together with consolidations. This has been corrected so the correct labels are printed even if the consignment are consolidated with or without a product change.
- If Sender Address ID was entered manually on Consignment but not set as mandatory in the setup no sender information was sent to LogTrade. This has been corrected.
- Invalid combinations of shipping agent, service and delivery term in default Terms of Delivery setup caused errors when entering Source Document No./Source No. in Consignment. This has been corrected.

# Version \*.03 (released 2012-11-08)

Version .03 introduces a new export/import which will make setup easier since the shipping agent mapping now can be exported/imported in the Setup Wizard. Besides that, version.03 is mostly about corrections/adjustments in pages for 2009 RTC and 2013.

### **New functionality:**

• It is now possible to export and import the mapping table for forwarders/products and shipping agents/-services. Export can be done at any time, but import is only possible when Setup wizard has been launched and mapping lines created and before settings has been implemented. Once the wizard has been run it is no longer possible to import mapping. The import will only update existing mapping lines so it's possible to have a generic mapping supporting all forwarders even though the customer does not have all these in the LogTrade License.

- It's no longer possible to import/export print queues since these are downloaded from LogTrade
- The field "Send Shipment Codeunit" was missing in advanced setup. This has been corrected.
- The relation to the user table in user setup has been corrected in the 2013-version
- Several layout changes in pages.

- Page 12057576 "LogTrade Ship. Serv. Prop." has been created
- It was not possible to download forwarders and products in the 2013-version if Domestic Country Code was not setup. This has been corrected.

## **New functionality:**

• Print Queues are no longer maintained manually. In the print queue list, there is now a function to get Print Queues from LogTrade. Print Queues are also imported automatically when running the Setup Wizard and if there is only one print queue that print queue will automatically be set as default print queue in the setup.

### Bug fixes/changes:

- When running the Setup Wizard there was a TESTFIELD on "Domestic Language Code" that gave an
  error. This has been corrected so that "Domestic Language Code" is no longer required on
  temporary consignments used e.g. for fetching forwarders and products
- The "Test Mode" checkbox has been moved from Advanced Setup to the regular setup form.

## \*.01 (released 2012-10-19)

- Demo Mode has been introduced. It is a setting in advanced settings. Once enabled these changes occur:
- Consignment No. will be set as a timestamp instead of using a No. series
- Consolidation ID will be set as 'DEMO'+[timestamp]. This together with Consignment No. as a timestamp will make it possible for partners to use a generic demo account at LogTrade.
- Package Tracking from released consignment will use hard coded dummy data to enable demo of package tracking without the need to create real consignments and have those transferred to Control Tower.
- Icons and actions have been updated on pages for released and archived consignments
- Swedish translation in Package Tracking corrected
- Control Tower password removed from setup since Control Tower web link is stored on the consignment
- "Control Tower Interface URL" in setup renamed to "Control Tower ERP Interface URL"
